

Speeding on the High Street and Tollgate Road featured high on residents' concerns in the survey by 4ColneyHeath residents' association issued in the Spring. The Parish Council have already taken action.

Bigger issues of concern raised were the proposed 6,000 houses on the Bowmans Cross development between Colney Heath and London Colney – see page 4. We expect many objections will be made. The Greenbelt and our environment are high priorities for many residents who understand the importance and value of our environment. Nearly 300 people requested their names be added to the "Colney Heath Precedent" letter being sent to members of parliament – see page 29

Since our last issue in May life for many has adjusted to the "new normal". Good to see activity returning to the Charles Morris Hall, see page 14. For some life has returned to something like the "old normal". The serious effects of Covid-19 are not widely experienced by younger people. Older people feel relieved of precautions by the protection of being double jabbed. We seem to be learning to live with, or ignoring, Covid. Meanwhile, the infection rate continues to rise.



#### We say GET JABBED!

Although post-COVID conditions appear to be less common in children and adolescents than in adults, long-term effects after COVID-19 do occur in children and adolescents.

Double jabbed people have been infected but the effects seem to be reduced. Everyone who is eligible for their top-up jab can now book an appointment online or by ringing 119 for a booster dose if it has been at least six months (182 days) since they had their second dose of the vaccine.

Hertsmere Borough Council have issued their draft Local Plan 2022-2038 for "consultation". This includes their proposal for the Bowman's Cross "new settlement" along Coursers Road on GREENFIELD LAND IN THE GREENBELT joining

London Colney with Colney Heath. By the House of Commons Library classification this will be a new small town (population between 7,500 and 25,000)

A few key points to note

Estimated new dwellings 2021/2-2037/8 2,400 Households total 6,000 Population Projected by the mid-2050's c.14,000

Employment office units (15,000 sq m), leisure and cultural facilities (6,000 sq m), convenience retail and dining (7,000 sq m)

It is noted that the new medical centre in London Colney will serve Bowmans Cross residents but dedicated health facility for Bowmans Cross will be delivered in the 2030s.

Proposed – but not when - are at least 4 primary school sites and at least one site for a secondary school (together with a reserve site for an additional secondary school).

Enhanced public transport through the site will include bus priority measures, pedestrian and cycle links to train stations nearby and other destinations.

#### **BOWMANS CROSS**



The developers, Urban and Civic plc say "the proposed site is shown (on the right) but less than 50% of the area will be buildings, with green buffers ensuring separation between communities, and extensive green space protecting important spaces for nature and providing open space for people."

The image below shows the approximate site boundary around greenfields in the Greenbelt with the partial area of quarry works.

#### WHAT WAS £100,000+ CASH SPENT ON?

From the Parish Council's website

Parish Council Press statement
This statement covers the period from 1st April
2004 until 10th July 2015 (which covers the late
Clerk John Deans tenure of Clerk to CHPC) and
ultra vires payments made during the period
totalling £ £254,767.29 (Note 1) representing
between 15% to 25% of the Parish precept every
year in that period (Note 2). This is detailed in the
attached report.

In the press statement there is no mention of the £100,000+ petty cash. You have to get to page 6 of the report to find the following

"Over £100,000 was taken from the NatWest bank account in petty cash. Most were signed with the cheque photocopied on the back of the payment approval sheet but there are no records of what this money was used for".

A response to a Freedom of Information request clarified that the petty cash amount was in addition to the £254,767.29 and "The Parish Council do not hold records to be able to provide an accurate sum of the petty cash withdrawn from 2004-2015 which is why the estimate of over £100,000 was used within the report".

#### **TONY BURNS ELECTED UNOPPOSED**

Tony Burns, long standing resident in Colney Heath village, was elected unopposed in September to the vacant seat in Colney Heath ward. Read the Q&A with Tony on page 13.

#### THE SCOUTS

The proposal by ClIr Graeme Shaw on the agenda for the Parish Council meeting on 21st October was "To resume the negotiations with the Scouts on the Heads of Terms agreement for a short-term agreement to occupy the Roestock Hut until such time as it is required to build a new facility on the site, or to meet any other agreed plans that arise from the Public Consultation."

The Scouts will have found the discussion disappointing as a number of reasons were given why negotiations will not resume.

#### LEGAL CLAIM AGAINST THE VILLAGE HALL

Having refused to mediate with the Colney Heath Village Hall, in January 2021 the Parish Council issued a legal claim to most of the Village Hall charity trustees in post in December 2017 Chris Brazier (former Parish Councillor), Dennis Horner (former Parish Councillor), Pam Fox, Gerry Savage (WI committee), Eddie Walsh.

Sophie Yates (owner of Treasure Tots pre-school).

Also named in the legal claim was the booking clerk Audrey Fowler, who was not a trustee. Named but not served with the claim were two other trustees your co-editor John Clemow and Anne Jarman.

Obviously having a legal claim against one in the County Court can be distressing especially if you are in your 80's, are frail, or a fearful mother of 3 young children.

At the Emergency Council Meeting held on 9<sup>th</sup> September the Parish Council decided that subject to agreement for parties to agree to pay their own costs and take no further action the legal case would be withdrawn. The trustees have spent a substantial sum on legal fees to defend the case but agreed to bear their own costs.

This matter is settled.

# EVICTED FROM COLNEY HEATH VILLAGE HALL

The Village Hall issued a s.25 notice to terminate the Council's occupation of the office space at the village hall (see the report from the Village Hall on page 15 for the reasons).

At the Emergency Council Meeting held on 9<sup>th</sup> September the Councillors unanimously resolved to accept the eviction notice issued by Village Hall and have vacated the space.

#### **PUBLIC CONSULTATION**

At the Parish Council meeting on 23<sup>rd</sup> September the Parish Council decided to appoint a commercial company to conduct a survey of residents' views both online and in hardcopy.

The agenda item does not make it clear what issues will be consulted upon but it is expected to include land owned by the Parish such as Gloucester Park and Horseshoe Field, and the proposed Community Hub (see right column).


# NEW COMMUNITY BUILDING IN ROESTOCK PARK?


From the Parish Council's website

"Roestock Hut

Due to some misreporting over the weekend and in order to clarify the current situation with the hut in Roestock Park, the Parish Council make the following statement:

The Parish Council have offered to build a new community building 1.5 times larger than the current hut with indoor sport facilities, more storage and inclusion of disabled access and facilities. It is hoped that this proposed community hub will still go ahead after a public consultation of all residents of the Parish. Any new building would be developed in conjunction with the Scout and Guide groups who raised funds, contributed to the fabric of and have been resident in the old and well loved building for many years."

An open letter was sent by one of your editors to the Parish Council which was discussed at the Parish Council meeting on 23<sup>rd</sup> September. The Councillors expressed appreciation and noted its contents. However, the agenda for the meeting contains an abridged version and omits several important points.

#### Will it be a liability?

To summarise, the Parish Council should provide their business case for this proposal – to demonstrate the expected income from lettings and the impact of the construction cost, and more important, the annual running costs on the Parish's accounts.

Before residents can sensibly respond to the Public Consultation on this proposal they should know if the proposal is financially viable – or if it is not, how much it will need to be subsidized from the tax payers' money that makes up the Council's income.

We think the business case should have been prepared before spending money to appoint an architect to do a design. We are also surprised to hear that the architect was verbally instructed and no record of what they were asked to design is available.

# BOWMANS CROSS NEW SMALL TOWN ON COURSERS ROAD

Unusually the Parish Council have waded in with "political" comments, reflecting the many concerns about Hertsmere Borough Council's proposal for a "new settlement" of 6,000 houses along Coursers

Cllr Cook does not mince his words in standing up for our community. In case you missed it, the following statement is on the Parish Council's website.

Colney Heath Parish Council remains opposed to the proposed development of 6000 homes at Bowmans Cross, on the boundary with Colney Heath and London Colney.

Councillor Peter Cook, Chairman of the Parish Council said, "One could easily conclude the Hertsmere Cabinet selected Bowmans Cross first and asked officers to write the report to reach the required result. It is a shrewd political move by Cllr Bright to ensure no opposition from Hertsmere electorate as no one lives in or near to the quarry and it reduces pressure on Radlett, Elstree, Bushey, and Potters Bar which are unsurprisingly the areas which most of their Cabinet represent.


The Garden village proposal evidence in the document shows poor sustainability of the site, harm to the Green Belt and major traffic issues – hardly a ringing endorsement for the Garden Village proposal. The site was initially promoted by an absentee land owner who stands to make considerable money from the land having already made it the rubbish dump of Hertfordshire with landfill, Bio digestor and composting units. As far as our research there are no other UK examples of housing being built on the site of a former quarry.

All the local roads already suffer from delays and congestion so building the proposed new Garden Village will make things much worse for residents not only in Colney Heath and London Colney but the wider area due to wide use of the immediate roads as 'rat runs' trying to avoid the delay of existing network.

We demand that our residents are properly consulted, given the impact that the development will have on the area including the increase in traffic movements through the village of Colney Heath."

Colney Heath Parish Council will continue to work with London Colney Parish Council to fight this development and will be jointly organising public meetings for residents to have their say. We would welcome Hertsmere Borough Councillors to attend these meetings.

#### **Current position in 2021**

St Albans City and District Council has a number of "wards" represented by District Councillors. The Colney Heath District Council ward is currently represented by Chris Brazier and Jamie Day.

The District ward boundary includes Highfield, Tyttenhanger Green, Oaklands, Smallford, Sleapshyde and Oaklands to the north of the A414 and Colney Heath village on the South side of the A414.




Figure 1 Current Boundaries in 2021 Boundary of District Council Colney Heath ward and Colney Heath Parish Council

The boundary of the Colney Heath Parish Council is currently the same the Colney Heath District ward boundary as shown on Figure 1 below

# The change to the District Council ward boundary




Figure 2 District ward boundary 2022 (outlined in red)

For the District Council elections to be held in May 2022 the Colney Heath ward will be "rural" area: Tyttenhanger Green, Smallford, Sleapshyde and Colney Heath village as shown on Figure 2 below

#### **Community Governance Review**

St Albans District Council Electoral Services is conducting a Community Governance Review. This can consider a number of issues, including whether to alter the boundary of the existing parish.

#### Indicative timetable

The initial public consultation will be carried out by the end of March 2022 and the process is planned to be complete for a decision by SADC by the end of 2022.

#### **Our opinion**

Your editors believe that boundary of Colney Heath Parish should be altered to be the same as the District ward boundary to form a "rural parish council" covering Tyttenhanger, Smallford, Sleapshyde and Colney Heath village effective from May 2023.

This would to recognize differences between the community interests: the community in the "urban" area, i.e. Highfield, associate with St Albans City.

The community in the rural area associate with their local settlements (Tyttenhanger Green, Smallford, Sleapshyde and Colney Heath village) while having the commonality of community concerns about protecting and enhancing rural culture and environment.

#### **Q&A WITH TONY BURNS**



Tony Burns was elected unopposed to the Colney Heath ward of the Parish Council in September 2021.

#### John

Tony, congratulations on being elected and well done for stepping up for the vacant seat on the Parish Council. Before we discuss why you stood for election, our readers who do not know you will be interested to know something about you and your connection with the village.

#### Tony

My family and I have lived in the village for over 40 years, initially in Franklin Close, then in Moonrakers and now in Roestock Lane. My children went to the village school and then on to secondary schools in St. Albans. I was on the Governing Body of the school for about 10 years and chaired it for most of that time. I am a long-standing member of the Colney Heath Boissy Twinning Association, which my wife Jackie chaired for several years, and also of Colney Heath Football Club where I lead the darts team.

#### John

So why do you want to be a Parish Councilor now?

#### Tony

There has recently been significant turnover of councillors for the Colney Heath ward of the Parish Council, this at a time when issues of great importance are being decided. I believe that it is desirable for the people of the village to have continuing and consistent representation in order that their views are considered in the decision-making process. It seems likely that the coming years will bring change and I hope to be able to play a part in ensuring the best possible outcomes for the village and also the wider parish.

#### John

From what you have seen so far what do think about the way Parish Council meetings are conducted?

#### Tony

For reasons relating to completion of formalities, so far I have not been able to participate in a meeting of the full council or of any sub-committee I have, however, attended meetings as a non-participant. It seems to me that the meetings are conducted efficiently, with the Chair giving all councillors the opportunity to contribute to the discussion. Meetings appear to follow the agenda closely and decisions are reached by open and fair voting. What I am less clear about is how the agendas are constructed (because this determines what is discussed) and how issues can be placed on an agenda. I hope to learn more about this in due course.



#### Johr

You were elected unopposed. Do you feel this to be a disadvantage compared with those Councilors who were elected in a contested election?

#### Tony

No. My election to the council was a result of due process, overseen by the Electoral Services of St. Albans District Council. My position on the council has the same democratic legitimacy as that of any other councillor.

#### John

The next Parish Council election will be in 18 months time in May 2023. What do you hope to achieve in this limited time? And what would like to see not happening?

#### Tonv

It seems likely that boundary changes will result in significant changes to the nature of the parish and, in consequence, the Parish Council itself. I think it is important that proper preparations for this change are made in order that the reconstituted council can be effective immediately. I would hope to be able to play a part in this. I am also keen to contribute to efforts to resist large-scale housing developments in and around the village. With regard to the great issue of the day, I will support the case for reconsideration of earlier decisions. We must recognise, however, that in the absence of any major change in the present situation, a majority of councillors consider the matter to be closed. If that remains the case the focus will move towards consideration of future possibilities and I would then seek to ensure a good outcome for the village and the redrawn parish

#### **CHARLES MORRIS HALL**





The Charles Morris Hall in Tyttenhanger Green

Like all other village halls, the Charles Morris Hall is slowly getting back to some normality following the various lockdowns. The Hall is used on a regular basis by the local communities for many activities including:

- Socatots, football-related physical development activities for young children aged between six months and five years
- There are three Pilates classes covering most ages.
- The Baby Sensory Classes are hugely popular. Their sessions engage babies, inspire parents and give that truly WOW factor through music, props, puppet shows, lights, bubbles and more!
- Various martial arts groups, including St Albans Ki Aikido, Borehamwood Ki Aikido, Karate and Tae Kwon Do, cater for all ages from children to adults.
- Sweaty Mama & Baby Exercise is a new class starting at the end of October. It is an effective way for mums to exercise with their children, gradually build up their fitness levels, strengthen their core and rehabilitate their body after having a baby. Add upbeat music and likeminded mums and fun is guaranteed.
- There are two very popular Yoga classes
- The watercolour workshop is a 10 week rolling programme covering all aspects of water colour painting.
- At the new Playball sessions, children are helped to develop fundamental building blocks of sport, agility balance and coordination, as well as the three key elements of physical fitness - endurance, strength and flexibility.
- Dawn To Dusk is a self-support group offering refreshments and therapeutic activities for carers, providing a two-hour respite from their caring duties and an opportunity to form friendships with other carers who understand the difficulties faced every day and the feeling of despair they can have at times caring for family or friends.

All the above regular groups use the Hall Monday to Friday while Saturday is kept for the 'casual' one off bookings such as parties, meetings and the occasional wedding reception and is particularly popular for children's parties.

A short version of the history of the Charles Morris Hall starts in 1921 when Charles Morris, who lived at Highfield Hall, made a Deed of Gift of 1.5 acres behind the houses numbering 34 to 52 Tyttenhanger Green, (to the left of the Plough) for the purposes of 19 allotments for the inhabitants of Tyttenhanger and later a charitable trust was created for the Tyttenhanger residents: "The Trustees of Charles Morris for allotments, Tyttenhanger Green".

Sadly Charles Morris died on 28<sup>th</sup> March 1926. In his will he left a piece of land (0.35 acres) "in Tyttenhanger Village which has been fenced off as the site for a village hall", together with another piece of attached land (0.79 acres), "for the benefit of the locality".

This land became vested in the Parish Council, as trustees, thereby creating a charitable trust "for the benefit of the inhabitants of Tyttenhanger Green".

6<sup>th</sup> May 1935 the playing field was opened. A plaque on the original gate bore the words: "In memory of Charles Morris and his wife Edith H. Morris, this playing field was purchased out of a bequest left by him for the benefit of the inhabitants of Tyttenhanger Green."

Over the years the allotments had fallen into disuse and in 1966 the Parish Council sought permission from the Charities Commission, to sell the land. It was the money from this sale that, together with grants, funded the building of the Charles Morris Hall and which was officially opened on 20<sup>th</sup> September 1975, and the following statement was made: "We are indeed delighted to do honour today to the name of Charles Morris, whose generosity so long ago has been the means of creating this fine asset for the residents of Tyttenhanger Green". The photo shows Parish Councillor A.G. Cutmore, his wife and the opening tape being cut by Mr. Herbert Mansell whose family had lived in the village.

Our differences with the Colney Heath Parish Council are, at long last, settled. We can put that unhappy state of affairs of the last 7 years behind us and get on with our work. The legal action against some of the current trustees, and the dispute over the Parish Council's non-payment for the office they used as a storeroom, have been an unwelcome distraction and incurred substantial and unnecessary financial costs. The mental distress suffered by some of the managing trustees who are vulnerable due to old age, sickness and personal circumstances has, to say the least, been unwelcome.

We do not expect an early change in attitude or approach from the Parish Council but we hope that in due course we will return to a good working relationship. We have plans for improvements at the village hall which will need the support of the Parish Council.

We get asked "so what on earth was it all about?". Here we provide what we hope is seen as a fair and objective summary. The full version ranks equal to a Norse saga.

#### The misunderstanding

In 1947 the Parish Council assumed the role of Custodian Trustee (from the Parish of St. Peter Rural) of the charity that was established in 1938 to build and manage the village hall. The 1938 Trust Deed is written in a way that many Parish Councils, and managing trustees, misinterpret to this day, leading to the mistaken belief that the Custodian Trustee owns a village hall. The role of the Custodian Trustee is simply to "hold the deeds on behalf of the charity".

#### The extension to the hall

As a millennium project, the village hall was extended to include a meeting room, a kitchen, disabled WC and a storeroom. It also included an

The Parish Council reportedly contributed £56,000, about half of the cost of the project. The minutes of a Parish Council meeting held on 11 September 2002 state "The Council do not appear to have a lease from the village hall setting out its terms of occupation. Members advised Council own the building & therefore Council advised this is not necessary." It is easy to see how the misunderstanding of ownership led to the Parish Council paying this proportion of the project cost, thinking perhaps they were investing in "their property".

#### The contribution

It was however agreed that for use of the office, free-of-charge Parish Council meetings in the meeting room, use of the kitchen etc, the Parish Council would pay the village hall a "contribution" instead of a fixed rent. The contribution was agreed on a formula and was paid by the Parish Council for the invoiced amounts from 2002 to 2015. The formula was based on the cost of the village hall utilities costs. This was a clever and flexible arrangement. These utility costs could rise, or fall, so the contribution related to the village hall's real costs, unlike a rental agreement with a fixed amount. The agreement was not formally documented.

#### The temperature rises

The Parish Council did get involved with the day to day management of the village hall, and paid for various items. The insurance issue (we won't bore you with the details) in 2014 sparked the start of serious concerns by the managing trustees about interference by the Parish Council.

The Parish Council election in 2015 and the Police investigation in 2016 into suspected fraud at the Parish Council, caused the Councillors to be concerned about many "irregular arrangements"

This was necessary but the way it was approached by the Parish Council resulted in considerable legal fees for both the Parish Council and the other parties involved.

#### The ownership issue

By 2014 the managing trustees realized that the Custodian Trustee did not own the village hall. The Parish Council had expressed their view that "we own the hall so why should we pay?". The managing trustees tried to engage with the Parish Council to get the matter settled, but to no avail.

In 2015 the managing trustees initiated the registration of the property with the Land Registry. The registered owner was shown as Colney Heath Parish Council as custodian trustee for Colney Heath Village Hall.

We appreciate that some Councillors believed this to mean the Parish Council owned the property. (we learned later that the Parish Council had included the village hall in the asset register in the sum of £686,700).

In 2016 the managing trustees decided to clarify the ownership and advised the Parish Council of their intention to change the Custodian Trustee from the Parish Council to the Official Custodian for Charities, part of the Charities Commission (we later learned that the Parish Council removed the village hall from their asset register from 2016).

The change to the Official Custodian for Charities was completed in 2017 and the Land Registry noted the registered owner as The Official Custodian for Charities on behalf of The Trustees Of Colney Heath Village Hall.

#### The contribution issue

The village hall's invoice for the contribution for 2015 was queried but eventually agreed for payment in April 2017. The managing trustees continued to issue invoices for the contribution viewing the payments by the Parish Council from 2002 to 2014 as evidence of an agreement (a contract established by conduct which we believed had legal force).

Parish Council had left the office in early 2017 as the space was too small for the additional staff they had employed, and moved the Parish Office to Alban Park.

As the space in the village hall was not occupied and the original purpose of access to the Clerk and other community services were not being provided, and the contribution for 2016 had not been paid, the managing trustees issued a "notice to quit" the office to the Parish Council in November 2017

#### The ownership issue again

At this point the Parish Council understood the Land Registry had recorded the Official Custodian for Charities as the registered owner of the village hall.

Parish Council instructed the solicitor who wrote to the trustees stating they were "currently investigating the circumstances in which our client has been divested of the legal interest of the freehold of the whole building, as Custodian Trustee" and requested we withdraw the eviction notice – which we did.

We responded "We hope that you have been able to explain to your clients the Colney Heath Parish Council ("CHPC") that the Village Hall in Colney Heath is not owned by them and never has been. The Custodian Trustee is appointed by the Managing Trustees and the Village Hall Council ("VHC") have now appointed the Official Custodian for Charities, who are part of the Charity Commission, as the new Custodian Trustee.

The Custodian Trustee does not have executive authority or responsibility, they are merely there to hold the deeds on behalf of the title owners. We have explained this on a number of occasions and even written an article for the Parish Magazine on the subject. This is explained simply for anyone to

In July 2017 the Parish Council stated that their internal auditor had noted that as the contribution arrangement was not a formal documented contract payment may be "ultra vires", the bill for 2016 was questioned, and they sought to reduce the contribution amount.

#### To and fro without resolution

From 2018 to the end of 2020 various attempts were made to resolve the dispute with many letters exchanged. The Parish Council had moved to an office in Highfield Park for an annual rent of more than £4,000.

In early 2019 it seemed a resolution was in sight when heads of terms for the Parish Council to rent the office were agreed. The Parish Council deferred concluding until after the May 2019 Parish Council election. However, in late 2019 they withdrew from the idea of a lease and proposed a contribution that was much lower than the original agreement amounting to around £200 per annum. This was not accepted.

In April 2020 the Colney Heath Village Hall Charitable Incorporated Organisation (CIO) took over from the original unincorporated charity, and the ownership of the village hall was subsequently recorded in the name of the CIO at the Land Registry. This was simply changing the name of the owner – evidence (if it were still needed) that a Custodian Trustee does not own a charity's property.

#### The legal claim for solicitor's fees

At the end of 2020 the Parish Council issued a preaction claim letter. It seemed to the trustees that the Parish Council were wanting the trustees to pay for the fees charged by the Parish Council's solicitor to "investigate the circumstances in which our client (ie the Parish Council) has been divested of the legal interest of the freehold of the whole building, as Custodian Trustee".

The managing trustees proposed mediation but this was declined.

In January 2021 the Parish Council made a formal claim in the County Court for the cost of their legal fees against the booking clerk and the managing trustees who had been in post in December 2017.

#### The "office"

In the Spring of 2021 the trustees issued a section 25 notice to terminate the Parish Council's use of the office space being used for storage.

In August the Parish Council proposed to lease the office and the trustees accepted this provided the rent the Parish Council had proposed was paid in advance, and the Parish Council paid the village hall's legal costs to prepare the lease.

#### Resolution

At the Parish Council's Emergency meeting in September 2021 they decided to quit the office by the end of October. The trustees agreed to contribute a compensation amount to the Parish Council. They also agreed to withdraw their claim against the booking clerk and the trustees subject to them not claiming for their legal costs. The trustees agreed.

#### Getting on with the job

The Parish Council seems to have assumed the Village Hall Trustees were benefitting in some way from their involvement with the Hall.

The Hall was originally built by unpaid volunteers from the Colney Heath village. The property is owned by a charity on behalf of the community. The trustees produce annual independently reviewed accounts. The trustees of the charity are unpaid volunteers responsible for ensuring that the charity remains viable in line with the Declaration of Trust created in 1936.

The charity charges all users to cover the cost of running the Hall and for funds to cover future repairs and improvements.

We have managed through the lockdown and emerged with a good number of regular hirers, several new to the hall (including Beavers and Cubs from the Scout Group). The hall is buzzing with life again and the trustees are planning various Having no other option (other than to settle what some viewed as being similar to extortion) the trustees appointed their solicitor to defend the case. The solicitor and the barrister who reviewed the Parish Council's claim advised the trustees that the claim would not stand up in court.

#### Newsletter

#### Survey: the results and progress

In February and April, we asked residents what issues they were concerned about. Speeding on the High Street and Tollgate Road were noted as one of the "top 5" concerns by residents. This issue was also on the Parish Council's "radar" who have advised the Clerk she had "applied for two speed indicator devices on 28th May 2021, application was confirmed as successful 4th October 2021. I have been contacted by HCC and am in the process of agreeing the locations so installation can commence.

We wrote to our County Councillor John Hale who responded on  $11^{\text{th}}$  October

**Speed Indicator Devices (SIDs)** These are the Smiley Face signs. Colney Heath Parish Council has asked for a grant from the Police and Crime Commissioner for SIDs for both the High Street and Tollgate Road.. I am hopeful we can get them installed in the next 12 months.

**20mph** I am also aware of some support for 20mph along the High Street (and possibly Tollgate Road?). The county council has agreed a policy for the introduction of 20mph. The policy is too restrictive and I suspect may prevent this as a solution, but I have asked for the list of areas that are being considered and, if the High Street is not on the list, will ask for it to be added.

HGVs Another issue that has been mentioned to me, particularly about the High Street is HGVs breaching the restriction. HCC have recently carried out a survey of such use, they used cameras at each end of the High Street to record HGVs to see how long they took to transit the High Street i.e. did they take so long that they presumably had a legitimate reason to be there as they stopped to load or unload. I asked the relevant officer about this last week and he was still waiting on the data. He is also going to look at whether improvements can be made to the signage.

One obstacle is that because of some of the businesses located off the High Street it will be difficult to put any form of restriction in the High Street to prevent HGVs using the road.

**Humps and Chicanes** Personally I prefer the use of chicanes to humps for slowing traffic and would like to see them introduced on the High Street. Although improvements to the humps would also be welcome.

A speed and volume survey was carried out on Tollgate Road in 2020, this is where traffic speeds and volumes are measured continuously for a week. The results showed that the average speed was slightly over 30mph. This means the road will not qualify for funding for traffic calming measures. Hopefully the SID will cause drivers to slow down.

It has probably been some time since a survey was carried out along the High Street, so I will see if one can be arranged for 2022. It will not be possible to get permission and funding for traffic calming measures without a survey. Once I have the results we can look at possible traffic calming measures, unfortunately I have a number of other roads where residents are keen to see such measures, so there is a resource issue.

#### Roundhouse Farm

We understand that Taylor Whimpey will be developing the site and wish to engage with the Parish Council on the next steps. The Parish Council wish to include 4ColneyHeath residents' association in the discussion.

#### **Community Summer Party**

Due to numbers being limited to 50 attendees we decided to cancel as this would not be a "community event".

#### Community park

Collaborative arrangements with Herts County Council for the maintenance of the "pocket park" between St Marks Church and the A414 have yet to be concluded.

#### **SMALLFOR RESIDENTS' ASSOCIATION**



Steve Ross, Secretary of SRA writes:

The 'hot' topic for Smallford remains the prospect of having a quarry on our doorstep (that is Ellenbrook and Colney Heath Parish fields) for the next 40 years in addition to CEMEX with all the issues that brings.

The current position is that a Planning Inquiry sits on the 16<sup>th</sup> November 2021 to consider the appeal by Brett Aggregates against Hertfordshire County Council's (HCC) decision to refuse permission for the quarry. There is a small team from Ellenbrook Residents' Association (ERA), Smallford Residents' Association (SRA) and Colney Heath Parish Council (CHPC) preparing for this enquiry.

Brett have at the same time submitted a second application (a new application) for a quarry on Ellenbrook Country Park. In Bretts' words, it deals with all the reasons that HCC refused the first. However, in our view it does not!

They appear to have designed this submission to coincide with the Inquiry with the intent of us having to deal with the Inquiry and also the new application and thus 'divide and conquer'. We needed to reply to the second application by the 22<sup>nd</sup> October 2021 with our submissions to the Inquiry due on the 16<sup>th</sup> October 2021. You can see this is fairly cynical!

It now transpires that the officers of Hertfordshire County Council have wrongly published this second application for consultation as it has not been vetted and indeed all the information was not received. This after it took them four months to issue the formal letter of rejection after the first application was turned down in September 2020, thus giving more time for Brett to organise their next move — one wonders whether it's just Brett we are up against.

As the situation now stands, we expect the consultation period for the second application to re-start shortly and last until the end of November.

#### WILDING COLNEY HEATH

It's in the news, many TV programmes, discussed by royalty and part of our own day to day experience – the uncomfortable fact that we (and in particular our children and grandchildren) are faced with a climate and biodiversity emergency.

So perhaps we should all reflect whether as a community we are doing all we can to contribute to actions to minimise the harmful outcomes foreseen.

With respect to nature, we have first hand experience in Colney Heath of the conflicts of conservation and the increasing demands for more land for development and the impacts of intensive agriculture. The on-going transition of our village location through developments such as the Bullens Green housing, the unauthorised Coursers Road travellers' site, and the proposed Bowmans Cross new town, highlight the importance of protecting the remaining havens for nature that are also essential for our own well-being.

Publicly owned land primarily managed to support nature locally are the Colney Heath Common Local Nature Reserve and the Colney Heath Community Park (there is also the Bullens Green woodland, planted as part of the Watling Chase Community Forest initiative that is largely located in Welwyn & Hatfield district and St Marks churchyard is part of the 'Living churchyards' scheme aimed at encouraging a wildlife rich habitat).

The Common has new adjacent development which resulted in unauthorised trenching across the Warren heathland in June 2020.

Major development is now threatened on its border (see draft Hertsmere Local Plan) which would further isolate wildlife and make the site more vulnerable and less able to recover from adverse periods of climate or other events. The Parish Council relinquished its responsibility for the Community Park in 2019 putting the site at risk of closure and for consideration for other uses.

Despite the considerable challenges, I have been encouraged by the efforts of our St Albans People & Wildlife Officer (Wilder St Albans) Officer who is working for St Albans District Council (on secondment from the Herts and Middlesex Wildlife Trust). Heidi Carruthers has visited our Community Park, our churchyard and Common (as well as the Smallford Station and Alban Way Heritage project) and met volunteers and officers to discuss how we can protect and enhance these sites. Heidi has confirmed just how important these sites are on a regional scale. But they need appropriate management, investment and a supportive community.

Are you interested in establishing a 'friends' group within 4ColneyHeath Residents Association? This will involve volunteer tasks (e.g., cutting hawthorn on the common, litter picking, managing the Community Park), and campaigning (e.g. for more roadside trees, cattle grazing on the Warren).

#### Improving the Environment around Smallford Station: A Significant Event

We've been planning this important collaborative community project for around three years now! Following very detailed preparation and advice, our Planning Application to SADC was heard and approved by their Planning Committee South on Monday 19<sup>th</sup> July 2021. However, the approval was conditional on a number of detailed points.


As well as our own Project Planning Team, we've been really lucky to have several important people 'on board' to support us. Frances Leonard is a St Albans District Councillor who has been a member of our Society for several years: She has been enthusiastically 'pushing our Project forward' and generously met the full cost of our Planning Application.

John Clemow is a retired Architect and David Lane a very successful Town Planner.

Both have generously provided their services for free and, with their encouragement and support, our formal Planning Application to SADC was successful.

SADC appointed Tom Hardy, Estate Services Manager, as our Liaison Officer and one of his team, Steve Dibben, Infrastructure Manager, is also involved.

Although we now have planning permission, we've not been able to proceed on improving the platform. We've yet to agree the Conditions set in the Planning Agreement with SADC. Before we can install the various items of 'furniture', SADC, led by Tom Hardy and his team, will be undertaking a range of improvement works - including resurfacing the platform making it safe and sound for the public to use, and building the platform extension providing part of the entrance to the goods van which will hold our exhibition.



#### **Collaborating with Oaklands College**

Art and Design Level 2 students participated in a competition to design art-deco-style railway posters and we chose five of them to be displayed on the platform alongside the items of 'furniture. We've had the designs enlarged and printed and were able to display them at our 'Heritage Open Day' Exhibition on Sunday 12<sup>th</sup> September – they made quite an impact!



Horticulture Students will be working on two raised flower beds that will sit on the platform and the embankment that runs along the car park. Trowel Trades students will be replacing old brickwork.








#### **COLNEY HEATH AND DISTRICT HISTORY SOCIETY**

#### THE COLNEY HEATH PRECEDENT



The following is the text of a letter signed by nearly 300 people that being sent to Members of Parliament

#### THE COLNEY HEATH PRECEDENT

We, the residents of Colney Heath village, request you urgently urge Ministers to ensure designated Greenbelt land is protected from the requirement for a 5 year supply of land, and housing shortage *per se*, which is resulting in the damaging exploitation by developers of inappropriate and unsustainable locations on greenfield sites within designated Greenbelt land

- a. by making the necessary changes to the National Planning Policy Framework (NPPF) and Planning Practice Guidance, and
- b. to include this protection in legislation so that "very special circumstances" under the NPPF cannot be misinterpreted and it is absolutely clear that greenfield and farmed land in the Greenbelt is protected.

If you agree read no further. If you doubt the reason for our request please make the time to read on.

#### WHY IS THIS IMPORTANT?

A Planning Inquiry was held in May this year into the appeal by the landowner and developer as consent was refused by the Local Authority for 100 houses on Bullens Green Lane, Colney Heath

on a greenfield farmland site in the designated Metropolitan Greenbelt which had never before been built on in any way.

The developer's case was principally that the lack of a 5 year supply of land, and the shortage of housing, were "very special circumstances" under the NPPF.

The Planning Inspector for the Inquiry considered that this had greater weight than the harm to the Greenbelt, and disregarded objections from the local authority and more than 200 objections from residents, and disregarded Ministers' statements, quoted in section 4 below, regarding the proper and democratic process for considering development in the Greenbelt.

Being in the lowest category of the Settlement Hierarchy, Colney Heath would never be included for development in a Local Plan.

#### **ABOUT COLNEY HEATH**

Colney Heath is a village in Hertfordshire in the metropolitan Greenbelt. It is not designated for development in the Local Plan and never would be. The village has around 700 properties and 1,220 registered electors. We have a church, a village hall, a pub, a coffee and cake café, a small shop/post office, a takeaway and a football club. We have strong community with a number of organizations, local societies and clubs. We are surrounded by farmland and woods with the Common being a designated nature reserve in the heart of the village.

Our village has a small junior school with one class per year group, that is usually full and already local families have struggled to obtain a place for their child. Herts County Council data shows that in the last 2 years the school had 45 applications for 30 places. This primary clearly cannot absorb the impacts of the additional development. Secondary schools are distant and places are subject to appeals every year. Some of our children have journeys of over an hour to the school places offered in surrounding areas. There are no health services in the village. There is no access to safe cycling routes out of the village. With very limited local facilities and very limited public transport, residents are totally reliant on the motor car for access to employment, schools, shopping etc.

The Inspector formed the opinion that bus services were adequate (they are clearly not) and the national cycling route (2 miles away) could be used for travel to work. A Planning Inquiry was held in March this year into the proposed housing development on "Smallford Works". That location is much closer to more frequent bus services to better destinations and is adjacent to the local national cycle route. The Inspector for the "Smallford Works" Inquiry deemed the bus services were inadequate and the cycle route useful for leisure purposes only.

Colney Heath is not a sustainable location for development beyond very limited infill.

#### **COLNEY HEATH IS "VERY SPECIAL"**

Being in the lowest category of the "settlement hierarchy", Counsel for the District Council advised the Planning Inquiry that our village "would never be included in a Local Plan".

On hearing the Inspector's decision Counsel for the developer's appeal wrote a blog entitled "What is so very special about Colney Heath?" which includes "There was no allocation. No proposed allocation. No element of previously developed land. No enabling development. Nothing, really.

No. This one's a pure Green Belt case. An open, green field on the edge of a village. And the circumstances which tipped the scales and won the day: **housing need**. Pure and simple."

We understand from the CPRE that the Inspector's decision for Colney Heath is already being cited as a precedent in planning applications.

#### STATEMENTS BY MINISTERS

The appeal decision by the Inspector disregards statements by Ministers which we quote as follows:

In a letter to Members of Parliament for English Constituencies dated the 7<sup>th</sup> June 2016, Brandon Lewis, the then Housing and Planning Minister stated "The framework makes it clear that innapropriate development may be allowed only where very special circumstances exist and that Green Belt boundaries should be adjusted only in exceptional circumstances, through the Local Plan process and with support of local people. We have been repeatedly clear that demand for housing alone will not change Green Belt boundaries."

In a letter dated 10<sup>th</sup> June 2016, Brandon Lewis stated "The Government is committed to maintaining strong protections for Green Belt. The National Planning Policy Framework makes it clear that inappropriate development should only be allowed where very special circumstances exist and that Green Belt boundaries adjusted only in exceptional circumstances, through the Local Plan process".

A letter to the RT Hon Theresa Villiers from the Rt Hon Sajid Javid, the then Secretary of State, on 27th October 2016 said

"It has never been the case that an area of Green Belt can never be altered, but any such changes are locally-led and can be made only in exceptional circumstances by means of the Local Plan process, following consultation and independent examination by a planning inspector to ensure that the plan is sound. We designed the Framework to be locally interpreted and applied, so we do not define exceptional circumstances. However, the supporting guidance reminds local authorities that, in planning to meet local housing needs, they must have regard to the Framework's policies on the protection of areas such as Green Belt, which indicates that development should be restricted and which may restrain the ability of an authority to meet its need".

In a letter of 9th October 2017 to the Rt Hon Chris Grayling, the Secretary of State said "Local authorities then need to determine whether there are environmental designations or other physical or policy constraints (such as Green Belt) which prevent them meeting their housing need".

This is again emphasized in a letter from the Secretary of State on the 27th April 2018 to Crispin Blunt MP. There is also the stricture to

"examine all other reasonable options for meeting their development needs, before concluding that any Green Belt land has to be released".

In a letter from the current Secretary of State, the Rt Hon Robert Jenrick, to the Rt Hon Theresa May dated the 19<sup>th</sup> July 2021 states.

"A local authority can alter the boundary of Green Belt land only in exceptional circumstances and where it can demonstrate that it has fully examined all other reasonable options for meeting its development need". Further "The Framework also makes clear that most new building is inappropriate in the Green Belt and should be refused planning permission unless there are very special circumstances. Some examples of these circumstances are listed in the Framework, such as buildings for agriculture, or limited infilling in villages".

We understand these statements mean changes to the Green Belt will be locally led. This was not the case in the Planning Inquiry for Bullens Green Lane, Colney Heath. Local people and the Councillors elected by them were against the application. We are outraged that the Planning Inspectorate, an unelected body, appointed an independent Inspector who does not live locally, has no vested interest in local planning matters, and who does not pay council tax in the area, has decided what is best for us and over the heads of the Council we have elected, and contrary to Ministers' statements.

The majority of residents' objections to the planning application were about the lack of school places, the lack of bus services, traffic congestion, and flooding adjacent to the development site. These were not just simple "NIMBY" reactions.


We would not have objected to some local "infilling" with genuinely affordable houses but now, with the addition of 100 houses, we say NO MORE!

#### THE REAL AND PRESENT DANGER

Developers and other parties have put forward parcels of farmland and fields surrounding our village in response to St Albans District Council's "call for sites" for the updating of the Council's Local Plan. These parcels comprise between 25 and 150 houses totaling more than 500 dwellings (in addition to the 100 that now have planning permission) and excluding the "housing-led mixed use.



These land owners and developers are unlikely to wait for St Albans District Council to update their Local Plan. They may be emboldened by the precedent of the Inspector's decision and appeal when their planning application is refused by the District Council. Our village would be swamped by piecemeal developments that individually would not justify the addition of the necessary supporting infrastructure. New and existing residents would be harmed, and the village environment destroyed.

The village comprises two parts, the original settlement to the north of the Common and subsequent development to the East of the Common.

The blue plots show farmland and fields offered for housing, the orange for housing-led mixed use.

Plot 668 has been granted consent by the Inspector of the Inquiry in July for 100 houses.

Plot 761 is housing-led mixed use, number of houses not given

#### THIS IS YOUR CONCERN

The appeal decision for Colney Heath is already being cited as a precedent in planning applications. It is likely to be repeated leading to many communities sharing our outrage.

Like us, many constituents who value the environment fear that the government is handing over housing policy to the house builders who are primarily interested in building "executive housing" on greenfield sites. These developments contribute little to the infrastructure and social costs needed to support this policy. The concern is that such an approach means the Greenbelt will be sacrificed to build unaffordable housing.

At the 2021 Conservative Party Conference in his keynote speech the Prime Minister stated "you can also see how much room there is to build the homes that young families need in this country

not on green fields not just jammed in the south east but beautiful homes on brownfield sites in places where homes make sense"

We ask you to do your utmost to ensure this aim is realised and it is this applied to housebuilding for all citizens.
